RESOLUTION NO. 382 S. 2022

SANGGUNIANG BAYAN RESOLUTION AUTHORIZING HON. RONALDOM. MORADA, MUNICIPAL MAYOR, BANSUD, ORIENTAL MINDORO, TO ENTER INTO CONTRACT WITH 876 CONSTRUCTION AND SUPPLY FOR THE CONCRETING OF ROAD AT SITIO MAGTANGGOL, BARANGAY PROPER BANSUD, BANSUD, ORIENTAL MINDORO, AMOUNTING TO ONE MILLION FOUR HUNDRED NINETY SEVEN THOUSAND NINE HUNDRED NINETY FOUR PESOS AND EIGHTY SIX (P1, 497,994.86) CENTAVOS

WHEREAS, Section 17a (viii) of the Local Government Code (LGC) of 1991 provides, and it reads, "That local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharge the duties and functions currently vested upon them including those of the national agencies and offices devolved to them xxx such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and infrastructure facilities intended primarily to service the needs of the residents of the municipality";

WHEREAS, pursuant to the aforementioned mandate and in order to enhance the socio-economic condition of all Bansudeños as contained in the development agenda of the present administration, the Municipal Government of Bansud has embarked on the provision of road construction and rehabilitation projects which include concreting of Farm-to-Market roads and other feeder roads in the municipality consistent to the "Build, Build, Build Program" of President Rodrigo R. Duterte;

WHEREAS, to defray the cost of the project, the municipality also utilize its own resources and has appropriated fund in the amount of One Million Five Hundred Thousand (P1, 500,000.00) Pesos from its 20% Development Fund in the 2021 Annual Budget;

WHEREAS, the municipal government through its Bid and Awards Committee (BAC) opened the bids for the purpose on December 21, 2021, which was won by the 876 Construction and Supply;

WHEREAS, Section 22 (c) of the Local Government Code provide, and it reads, "No Contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned, unless otherwise provided in the Code";

WHEREAS, after a thorough deliberation, the Sangguniang Bayan of Bansud has expressed its collective decision in granting legislative authorization in favor of the municipal mayor to enter into contract with the abovementioned contractor;


NOW, THEREFORE, though a Motion of Hon. Romell G. Hernandez, Chairperson, Committee on Public Works, duly seconded by Hon. Carlito M. De Castro and of all members present;

BE IT RESOLVED, as it is hereby resolved, to authorize Hon. Ronaldo M. Morada, Municipal Mayor, Bansud, Oriental Mindoro, to Enter Into Contract with 876 Construction and Supply, for the concreting of road at Sitio Magtanggol, Barangay Proper Bansud, Bansud, Oriental Mindoro, in the amount of One Million Four Hundred Ninety Seven Thousand Nine Hundred Ninety Four Pesos and Eighty Six (P1, 497, 994.86) Centavos;


RESOLVED FINALLY, to send copy of this resolution to **Hon. Ronaldo M. Morada**, Municipal Mayor, Bansud, Oriental Mindoro and to **876 Construction and Supply**, Barangay Malamig, Calapan City, Oriental Mindoro, for their information, reference and appropriate action.
