RESOLUTION NO. 384 S. 2022

SANGGUNIANG BAYAN RESOLUTION EXTENDING THE DEADLINE OF PAYMENT OF MUNICIPAL PERMITS, LICENSES AND FEES WITHOUT PENALTIES, INTEREST AND SURCHARGES UNTIL MARCH 30, 2022

WHEREAS, the Local Government Code of 1991 and the 1194 Revenue Code of of the municipality of Bansud provide for the impositionof taxes and fees such as but not limited to Real Property Tax, Business Tax, Trasfer Tax, Franchise Tax and Amusement Tax, the payment of which beyond the deadline set by law or ordinances results to the imposition of surcharges, penalties and interests;

WHEREAS, Article 255, Rule II of the Implementing Rules and Regulations (IRRs) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, provides and its reads, "All local taxes, fees, and charges due and accruing to the local government units (LGUs) shall be paid within the first Twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reasonor cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding Six (6) months";

WHEREAS, as the Covid-19 continues to spread and its economic impact is now being felt by all sectors, there is a need to extend the deadline of payment of municipality's taxes to spare Bansud taxpayers the penalty, surcharge and interest resulting from their inability to timely pay the taxes due to restricted mobility, economic disruption, financial hardship and ultimately soften the harsh financial impact;

WHEREAS, considering the provision of temporary economic relief to individuals and businesses in the municipality, the Sangguniang Bayan of Bansud after a thorough deliberation, has expressed its collective decision in extending the deadline of payment of municipal permits, licenses and fees;


