**AN ORDER CREATING THE TEAM RESPONSIBLE FOR THE  
FORMULATION OF COVID-19 VACCINATION PLAN OF BANSUD,  
ORIENTAL MINDORO**

**WHEREAS**, Proclamation 922 and 1021 series of 2020 declared the Philippines under State of Public Health Emergency and State of Calamity due to the COVID-19 pandemic;

**WHEREAS**, Republic Act 11469 or the Bayanihan to Heal as One Act authorizes the President to suppress the COVID-19 pandemic through the procurement of drugs and vaccines;

**WHEREAS**, DILG Memorandum Circular 2021-007 dated January 18, 2021 provides interim Preparatory Guidelines in the implementation of the National Vaccination Program;

**WHEREAS**, the aforementioned guidelines directed LGUs to prepare vaccination plan in compliance to the DOH Guidelines on the National Vaccination Program and in coordination with the respective DOH Centers for Health Development;

**NOW THEREFORE**, I, **RONALDO M. MORADA**, Municipal Mayor of Bansud, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the creation of the **Team responsible for the formulation of COVID-19 Vaccination Plan of Bansud, Oriental Mindoro**, as follows;

**Section 3. EFFECTIVITY.** This Executive Order shall take effect immediately upon approval.
