**CREATION OF LGU INSPECTION AND CERTIFICATION COMMITTEE AND  
DILG INSPECTION AND CERTIFICATION TEAMS FOR SAFETY SEAL  
CERTIFICATION OF BANSUD, ORIENTAL MINDORO**

**WHEREAS**, Section 15 Article III of the 1987 Philippine Constitution mandates that "The state shall protect and promote the right to health of the people and instill health consciousness among them";

**WHEREAS**, the presence of new variant of SARS-COV-2 which originated from United Kingdom and South Africa (501.2) has been confirmed in the Philippines and are believed to be one of the major factors affecting the surge in cases of COVID-19 in the country;

**WHEREAS**, to contain the spread of COVID-19 and prevent surges, there is a need to enforce strict and continual compliance with the Minimum Public Health Standard (MPHS) especially in business establishments and major public places;

**WHEREAS**, DOLE-DOH-DILG-DTI Joint Memorandum Circular 21-01 provides guidelines in the implementation of the Safety Seal Certification;

**WHEREAS**, DILG Memorandum Circular 2021-053 indicates that the Department and the LGUs are the issuing authorities and there must be Creation of Inspection and Certification Teams for public offices and other establishments;

**NOW THEREFORE, I, RONALDO M. MORADA**, Municipal Mayor of Bansud, Oriental Mindoro, by virtue of powers vested in me by law, do hereby order the Creation of LGU Inspection and Certification Teams for Safety Seal Certification within the Municipality of Bansud, Oriental Mindoro.

a. Assigned Establishments. The following are the assigned establishments to be inspected and monitored by the LGUs and the DILG Team:

b. Keep record of the establishments it has awarded with the Safety Seal and shall post in the issuing Authority's official Facebook Page for transparency purposes.

c. To encourage the public to report non-compliance with the minimum public health standards.

d. To encourage the public to use the StaySafe.Ph application.

e. To have and maintain hotline numbers, Public Assistance and Complaints Desk to receive complaints and queries.

f. Regularly monitor and determine the eligibility of establishments onsite.

g. Submit the biweekly (every 2 weeks) accomplishment report to the Provincial office, which shall include but not limited to the number and nature of establishment given the Safety Seal and the number and nature of complaints received.

**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately upon its approval.
