**RE-DESIGNATION/APPOINTMENT OF LOCAL ECONOMIC  
DEVELOPMENT AND INVESTMENT PROMOTIONS OFFICER AND  
CREATION/RECONSTITUTION OF LOCAL ECONOMIC DEVELOPMENT  
AND INVESTMENT PROMOTION TEAM/OFFICE**

**WHEREAS**, the local governments play an active role in attracting more investments by providing an enabling environment that will generate and enhance economic activities in the locality;

**WHEREAS**, the Department of the Interior and Local Government issued Memorandum Circular 2010-113 entitled "Designation of Local Economic and Investment Promotion Officer" and Memorandum Circular 2020-167 entitled "Guidelines on Promoting Local Economic Development and Investment Promotion and Establishment of LEDIP Office/Unit in all Provinces, Cities and Municipalities".

**WHEREAS**, it is the policy of the Municipality of Bansud to encourage both local and Foreign investments in its jurisdiction that will result in the mutual benefits of its citizens and investors, taking into account the principles of sustainable development, wise utilization of natural resources, equitable distribution of wealth and holistic human resource development;

**WHEREAS**, to spearhead local economic growth and development there is a need for the LGU to re-designate/appointed the LEDIPO;

**NOW THEREFORE, I, RONALDO M. MORADA**, Municipal Mayor of Bansud, Oriental Mindoro, by virtue of powers vested in me by law, do hereby order the Re-Designation/Appointed of Local Economic Development and Investments Promotions Officer and Creation/Reconstitution of Local Economic Development and Investment Promotion Team/Office within the Municipality of Bansud, Oriental Mindoro.

**SECTION 1. LEDIPO DESIGNATION**

This is to hereby designate **Mr. Manuel I. Regencia** the Municipal Planning and Development Coordinator as the Local Economic Development and Investment Promotions Officer (LEDIPO) of the Municipality of Bansud.

**SECTION 2. LEDIP TEAM**

### **SECTION 3. DUTIES AND FUNCTIONS**

The LEDIPO and LEDIP shall perform the following duties and functions:

1. Facilitate the preparation, coordination and execution of the municipal economic and investment promotion policies, projects and activities of the municipal governments;
2. Facilitate the establishment of an aggressive, systematic, coordinated and sustained promotion and marketing of the LGU investment location;
3. Provide basic information about the business potential of the LGU to prospective investors to attract more investments to flow-in the municipality;
4. Establish a local economic Data Base containing relevant facts and figures;
5. Coordinate with other offices in the promotion of economics activities such as the Planning and Development, Treasury and Budget Offices and the Sanggunian;
6. Coordinate with the private sector in investment promotion campaigns;
7. Conduct information dissemination on local government policies on investment, investment wage laws, required permits, etc.

### **SECTION 4. DESIGNATED OFFICE**

The LEDIPO shall temporarily hold office at the **Municipal Planning and Development Office**.

**SECTION 5. EFFECTIVITY.** This Executive Order shall take effect immediately upon its approval.
