EXECUTIVE ORDER NO. 11 Series of 2021

REORGANIZATION AND STRENGTHENING OF KALAHI-CIDSS – NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROGRAM- ADDITIONAL FUNDING MUNICIPAL INTER-AGENCY COMMITTEE- LOCAL POVERTY REDUCTION ACTION TEAM (KC-NCDDP-AF –MIAC- LPRAT) THAT WILL SERVE AS AN ARM OF LOCAL GOVERNMENT OF BANSUD ON LOCAL POVERTY REDUCTION, DEFINING ITS FUNCTIONS AND RESPONSIBILITIES AND PROVIDING FUNDS FOR ITS OPERATIONS.

WHEREAS, the Department of Social Welfare and Development (DSWD) envisions society where the poor, vulnerable and disadvantaged individuals, families and communities are empowered for an improved quality of life.

WHEREAS, under the Local Government Code, the local government units are mandated to empower the people through direct participation in the affairs of government, by allowing them the widest possible space to decide, initiate and innovate.

WHEREAS, the project aimed at developing and implementing social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in the Municipality;

WHEREAS, the Municipality of Bansud and all of its 13 Barangays as one of the site for the implementations of the program;

WHEREAS, DILG MEMORANDUM CIRCULAR NO. 2004-62, enjoining and requesting the support of the Local Government Units (Provincial, Municipal, and Barangay Level) in KALAHI-CIDSS projects by providing necessary support and assistance.

NOW THEREFORE I, **RONALDO M. MORADA**, Municipal Mayor of Bansud, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby ordain and promulgate this Executive Order for the Reorganization of Municipal Inter-Agency Committee- Local Poverty Reduction Action Team (MIAC- LPRAT) for KALAHI – CIDSS- NCDDP- AF in the Municipality of Bansud, Oriental Mindoro.

SECTION 1. TITLE. That the committee shall be known as KC-NCDDP Municipal Inter-Agency Committee – Local Poverty Reduction Action Team (KC-NCDDP- AF- MIAC- LPRAT);

SECTION 3. FUNCTIONS:

1. Provide technical review and support during project implementation
2. Coordinate with various concerned national government and non-government agencies on project, plans and activities that will address poverty reduction through Inter-Agency Council Meeting

3. Ensure support to KC-NCDDP- AF by providing budget allocation in the Annual Investment Plan and Comprehensive Development Plan as funding counterpart from the Municipal Government of Bansud
4. Provide technical assistance in all Barangays of the Municipality in the preparation of Barangay Development Plan (BDP) and inclusion of BDP to Municipal Development Plan (MDP)
5. Assist in the conduct of Community Assembly Meetings and Provide Orientation on the identification and selection of community – driven problem
6. Advocate the participation of non-government organization and people's organization during project implementation and monitoring
7. Conduct regular meeting and dialogue- consultation in order to raise issues and concerns and to come up with recommendation/s.
8. Conduct team building activities that will ensure harmonious working relationship of different stakeholders
9. Advocate for the accreditation of NGO-PO to the Sanggunian Bayan
10. Ensure participation and representation of POs-NGOs in different Local Special Bodies
11. Harmonize Municipal and Barangay GAD Plans and ensure prioritization of GAD- funded projects and subject the said plans for participatory review and assessment on gender responsiveness and make possible enhancement or recommendations

SECTION 4. FUNDING. To ensure sustainability and strengthening of KC- NCDDP- MIAC- AF -LPRAT, the Local Government Unit will provide funds or a certain portion of funds allocated under KC-NCDDP- AF and to allocate funds under the Office of the Municipal Mayor for Trainings and Grants to funds for its mobilization activities.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately upon its approval and shall remain enforce unless otherwise revoked. Let copies of this E.O 11 Series of 2021 be furnished to all concerned for their information, reference and guidance.
