EXECUTIVE ORDER NO. 20 SERIES OF 2021

PLACING SITIO CENTRO OF BARANGAY VILLA-PAGASA, BANSUD, ORIENTAL MINDORO UNDER "GRANULAR LOCKDOWN" EFFECTIVE AUGUST 24 - 2021 UP TO SEPTEMBER 07, 2021

WHEREAS, COVID-19 virus pandemic continues to cause damage to health, safety and economic activities of the people,

WHEREAS, the Philippines is still in the state of health emergency and the cases of COVID-19 virus has again been rising,

WHEREAS, as per report of the Barangay Officials of Barangay Villa-Pagasa and the Municipal Health Office of Bansud, there had been three (3) deaths due to COVID-19 at Sitio Centro of Barangay Villa-Pagasa, Bansud, Oriental Mindoro

WHEREAS, as per recommendation of the Municipal IATF in order to prevent the spread of virus in the area and to protect the health and safety of the people, there is an urgent need to place the said area in "Granular Lockdown",

NOW, THEREFORE, I, RONALDO M. MORADA, Municipal Mayor of Bansud Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Declaration of Granular Lockdown.

Sitio Centro of Barangay Villa-Pagasa shall be placed under "Granular Lockdown" effective August 24, 2021 up to September 07, 2021

All residents therein shall be under quarantine and there will be no movements of people therein..

SECTION 2. Immediate Action of the Concerned Barangay and Departments/Offices.

A. Barangay Officials

1. Barangay Villa-Pagasa thru the Barangay Captain shall mobilize all Barangay Officials and the BHERT to immediately secure the affected area and all households shall be place on quarantine for fourteen (14) days.
2. Prepare report and submit to the Office of the Mayor the number of affected household, families and the total population.
3. Deploy Barangay Police to assist in the control of the movement of people.

B. Philippine National Police

1. Deploy Police Officers in the area and implement strictly the "Granular Lockdown".

2. Submit regular report to the Office of the Mayor.

C. Municipal Social Welfare and Development Office

1. Provide assistance to the affected households/families in the form of food packs and other needed supplies and materials.

D. Municipal Health Office

1. Conduct contract tracing.
2. Provide health and medical services
3. Submit timely report on the prevailing situation.
4. Recommend immediate action.

E. Municipal Disaster Risk Reduction Management Office

1. Monitor and report on the situation of the area and provide assistance if needed.

F. Office of the Municipal Administrator

1. Coordinate all activities/actions and report to the Mayor from time to time.

SECTION 3. Effectivity.

This Executive Order shall take effect immediately.
