EXECUTIVE ORDER NO. 21 SERIES OF 2021

AN EXECUTIVE ORDER REORGANIZING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDRED (LCAT - VAWC)

WHEREAS, Republic Act No. 9208 declares that the State shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect the people from violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation, and reintegration;

WHEREAS, Republic Act No. 9262 underscores the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security;

WHEREAS, Section 102 of the Local Government Code of 1991 provides for the mandatory creation of Local Committee on Anti-Trafficking and Violence Against Women and their Childred (LCAT - VAWC) in every local government unit;

WHEREAS, there is a need to establish functional and parallel structure and system at the local level which will monitor and oversee the implementation of the provision of RAs 9208 and 9262 and other women/VAW-related laws and policies;

NOW, THEREFORE, I, RONALDO M. MORADA, Municipal Mayor of Bansud Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the reorganization of Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) of the Municipality of Bansud.

SECTION 1. Composition

The Local Committee on Anti-Trafficking and Violence Against Women and their Childred (LCAT-VAWC) shall be composed of the following:

SECTION 2. Functions

The Local Committee on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) shall perform the following functions:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (formulate local ordinances and resolutions);
2. Create and establish systems on surveillance, investigation, and rescue to ensure effective and efficient coordination;
3. Undertake information, education and advocacy campaign against trafficking in person and violence against women and children;
4. Monitor and oversee the strict implementation of RA 9208, RA 9262 and other related laws for the protection of women and children, and of the local committee in Anti-Trafficking and Violence Against Women and Children (LCAT-VAWC) national plan of action; and
5. Implement the programs and activities as stated in the national plan of action.


SECTION 3. Institutional Arrangement and Coordinating Procedures

The Institutional Arrangements and Coordinating Procedures for the Local Committee on Anti-Trafficking and VAWC (LCAT-VAWC) shall be guided by the Section 4 of the DILG, DSWD, DOJ Joint Memorandum Circular No. 2010-1 dated 18 October 2010, which provides creation of Local Committee on Anti-Trafficking and Violence Against Women and their Childred (LCAT-VAWC)

SECTION 4. Effectivity.

This Executive Order shall take effect immediately.
