WHEREAS, from then on, MIMAROPA trainees were sent at CALABARZON training center until 2017 but when P/LT. COL. Roberto R. Odiver, Jr. became the Training Director of the RTC4, he has initiated the outsourcing of available land within southern tagalog provinces purposely to establish additional training grounds;

WHEREAS, with the unwavering effort of P/LT. COL. Roberto R. Odiver, Jr., on September 4, 2018, Regional Training Center for MIMAROPA has been established in Bansud, Oriental Mindoro;

WHEREAS, as the current chief of the RTC-MIMAROPA, P/LT. COL. Roberto R. Odiver, Jr., has extended his meritorious effort and valuable support to the municipality of Bansud not only by developing the character of “discipline” among trainees, but by providing guidance to the local government when it comes to peace and order and public safety especially in time of COVID-19 Pandemic;

WHEREAS, hence, if only to show appreciation of Bansudeños, the 18th Sangguniang Bayan of Bansud, Oriental Mindoro, has expressed its collective decision in commending PLTCOL Roberto R Odiver, Jr., Director, PNP- RTC-MIMAROPA, for his meritorious effort and valuable support in the establishment of PNP Regional Training Center in the municipality of Bansud, Oriental Mindoro;
