SANGGUNIANG BAYAN RESOLUTION COMMENDING P/LT. COL. RONNIE R VISCO, ASSISTANT CHIEF, PHILIPPINE NATIONAL POLICE (PNP) REGIONAL SPECIAL TRAINING UNIT (RSTU)-MIMAROPA FOR HIS MERITORIOUS EFFORT AND VALUABLE SUPPORT IN THE ESTABLISHMENT OF PNP REGIONAL SPECIAL TRAINING UNIT IN THE MUNICIPALITY OF BANSUD, ORIENTAL MINDORO

WHEREAS, in 2002, Regional Special Training Unit (RSTU) was established at Camp Efigenio C. Navarro, in Calapan City, Oriental Mindoro, which was developed for administrative and operational functions and caters to the mandatory and specialized training needs of the PNP personnel of the MIMAROPA region composed of Occidental and Oriental Mindoro, Marinduque, Romblon and Palawan;

WHEREAS, from then on, the Regional Special Training Unit (RSTU) is occupying the One Hundred (100) Square Meter space for its offices and facilities inside the abovementioned camp, but due to its limited area, the same cannot accommodate the influx of MIMAROPA trainees and often sent them back to CALABARZON training center until 2016;

WHEREAS, it was in the same year when **P/LT. COL. RONNIE R VISCO**, who was the current Training Manager of the RSTU, has initiated the outsourcing of available land within Oriental Mindoro province purposely to establish a conducive and well- equipped training grounds and has sought the assistance of LGU Bansud;

WHEREAS, with the unwavering effort of **P/LT. COL. RONNIE R VISCO**, on May 2016, the municipal government of Bansud has responded to his request and has specifically earmarked a lot containing an area of Eighty One Thousand Six Hundred Eleven (81,611) Square Meters and eventually on September 8, 2016, the Regional Special Training Unit (RSTU) was established in the municipality;

WHEREAS, for almost Eight (8) years of tour of duty as Training Manager/ Assistant Chief of RSTU-MIMAROPA, **P/LT. COL. RONNIE R VISCO** have displayed exemplary stewardship among our ECO WARRIORS by developing their knowledge and skills and instilled them the character of “discipline” and likewise extended his meritorious effort and valuable guidance to the municipality of Bansud in the maintenance of peace and order, and public safety especially now that we are enduring the onslaught of COVID-19 Pandemic;

WHEREAS, it has been observed that the establishment of RSTU-MIMAROPA not only respond to the pressing needs for delivering necessary training services in the region but also contributed to the economic development of the locality;

WHEREAS, hence, to express the utmost recognition and appreciation of Bansudeños to his exemplary service to the people, the 18th Sangguniang Bayan of Bansud, Oriental Mindoro, had decided to commend **P/LT. COL.
