RESOLUTION NO. 195 S. 2020

SANGGUNIANG BAYAN RESOLUTION APPROVING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (MDRRMFIP) CY 2020 OF THE MUNICIPALITY OF BANSUD, ORIENTAL MINDORO

WHEREAS, Section 2 (a) of the Republic Act 10121 also known as the “Philippine Disaster Risk Reduction and Management Act of 2010” provides, and it reads: “That it shall be the policy of the State to uphold the constitutional rights to life and property by addressing the root causes of vulnerability to disasters, strengthening the country’s institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts”;

WHEREAS, likewise, Section 2 (e) of the same act also provides that the State shall develop, promote and implement a comprehensive National Disaster Risk Reduction and Management Plan (NDRRMP) that aims to strengthen the capacity of the national government and the local government units (LGUs), together with partner stakeholders, to build the disaster resilience of communities, and to institutionalize arrangements and measure for reducing disaster risks, including projected climate risks, and enhancing disaster preparedness and response capabilities at all levels;

WHEREAS, pursuant to the said mandate, the Office of the Civil Defense (OCD), through its Regional Disaster Risk Reduction and Management Council (RDRRMC), recognizes and strengthens the capacities of Local Government Units (LGUs) and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

WHEREAS, in compliance therewith, the municipality of Bansud through its Municipal Disaster Risk Reduction and Management Council (MDRRMC) has formulated a Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) for CY 2020 which was approved during its council meeting held on August 14, 2020, at Regional Evacuation Center;

WHEREAS, after a thorough deliberation, and finding that the said Plan has contained all necessary programs/projects/activities for disaster risk reduction and management operations including all the mitigating measures of containing and eliminating the threat of COVID-19, the Sangguniang Bayan of Bansud has expressed its collective decision in approving the same;


NOW, THEREFORE, through a Motion of Hon. William C. Evangelista, Chairperson, Committee on Women, Family and Social Welfare, duly seconded by Hon. Crispin E. Cabral and all members present;

BE IT RESOLVED, as it is hereby resolved, to approve the Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) CY 2020 of the municipality of Bansud, Oriental Mindoro;

RESOLVED FINALLY, to send copy of this resolution to the Office of the Municipal Disaster Risk Reduction and Management through **Mr. Donato A. Sanchez**, LDRRMO III, Bansud, Oriental Mindoro, for his information, reference and appropriate action.
